## OFFICIAL RULES OF THE ATLANTA JAMAICAN ASSOCIATION, INC. ('AJA' the SPONSOR"), 1<sup>ST</sup> MEGA CAR RAFFLE ('the Raffle').

*By entering the Atlanta Jamaican Association Inc, 1<sup>st</sup> MEGA CAR RAFFLE ('The Raffle'), you consent and agree to be bound by the Official Rules. Accordingly, you should read these rules carefully before entering the Raffle.*

- 1. ORGANIZATION CONDUCTING THE RAFFLE:** The Raffle is being conducted by the Atlanta Jamaican Association ("AJA"), which is solely responsible for the Raffle, the administration of these Official Rules, and the awarding of prizes. Net proceeds from the Raffle will benefit AJA's Cultural Center Fund, Scholarships and Outreach programs. The RAFFLE will be conducted by random drawing on Saturday, May 30, 2009.
- 2. ELIGIBILITY:** To be eligible to enter the Raffle, each participant must comply with these Official Rules, and must be legal residents of the United States of America, and must be 18 years of age or older. The winner of the Grand Prize and any other prize must provide proof of eligibility, proper identification and social security number when claiming their prize. The Executive Board of the Atlanta Jamaican Association and members of the Raffle Committee are not eligible to participate.
- 3. HOW TO ENTER:** To enter the Raffle, participants must purchase Raffle tickets from an authorized volunteer, approved by AJA; complete the ticket stub(s), then submit the completed ticket stub(s) along with cash, check, or money order to one of AJA's authorized volunteers. Tickets may also be purchased by internet as follows: Access the official website of AJA, at [www.ajaatlanta.org](http://www.ajaatlanta.org), navigate to the 1<sup>st</sup> MEGA RAFFLE entry page, complete the Raffle entry form, then 'submit' the completed form along with all required credit card information via PAYPAL. All internet purchases will be assigned a ticket, the 'stub' of which will be entered for the May 30<sup>th</sup> drawing. After confirmation of payment, the AJA will inform the internet purchaser (by e-mail or regular mail) of the raffle ticket number assigned. A participant may enter as often as he/she wants. Only one name can be assigned to a ticket and will not be changed. Any Raffle ticket order received for which the credit card payment or check is rejected or dishonored for any reason, will be VOID. The deadline for internet purchases is 12:00 Midnight on Friday, May 29, 2009. Tickets, if available, may be purchased in person up to 5:00PM on the night of the drawing, Saturday, May 30, 2009. Payments received for purchases made after the deadlines will be returned.
- 4. PRIZES:** Prizes will be as follows: the GRAND PRIZE-2009 Toyota Corolla XLE: 2nd Prize vacation for 2, to a Jamaican Resort or similar destination; 3rd. Prize 3 days 2 nights to Hawaii or similar destination: 10 consolation prizes. In the event a minimum of 2,500 tickets are not sold by May 29th, or any extended date, the AJA reserves the right to withdraw the car prize (the GRAND PRIZE) and pay 50% of the net proceeds to the GRAND PRIZE winner. The GRAND PRIZE will be available at a local Toyota Dealership. If any winner is unable or unwilling to take possession of the prize to which the winner is entitled, there will be no substitution or exchange for cash or other goods.

5. **NUMBER OF ENTRIES:** No more than 6000 Tickets will be sold for this Raffle. AJA shall keep a detailed record of ticket stubs received and accepted.
6. **METHOD OF AWARDING PRIZES:** AJA will conduct random drawings for the GRAND PRIZE and all other prizes on May 30, 2009. The winners need not be present at the drawing to win. Prize winners will be notified by mail, telephone and /or email. All winners will be posted on the AJA website at [www.ajaatlanta.org](http://www.ajaatlanta.org).
7. **GOVERNING LAW/JURISDICTION:** All issues concerning the validity and enforceability of these Official Rules or the rights and obligations of the participants shall be governed by and construed in accordance with the laws of the state of Georgia. The invalidity or unenforceability of any provision of these rules shall not affect the validity of any other Official Rule. Each person who participates in the Raffle agrees that the exclusive venue for the resolution of any dispute or legal question shall be in the county of Dekalb in the state of Georgia and waives any right to proceed in any other jurisdiction.

## GENERAL CONDITIONS

- **The winner(s) must execute and provide to AJA:** An Affidavit of Eligibility, attesting to the winner's eligibility and compliance with the Official Rules; a Liability Release, releasing AJA and any sponsor or volunteer, from any and all liability arising out of 'the RAFFLE'; a Publicity Release, allowing AJA to use the name, likeness, voice and biographical information of any winner, for publicity purposes. The winner(s) will also be required to provide any other information needed by AJA to comply with applicable laws and regulations- including those relating to the paying of income or ad valorem taxes.
- **Liability:** In no event will AJA or its Executive Board members, or its affiliate, be liable for any damages or losses of any kind including direct, indirect, incidental, consequential, statutory or punitive damages with respect to 'the RAFFLE' and to the prizes. AJA or its Executive Board makes no warranty of any kind either expressed or implied.
- **Taxes:** All taxes, fees, assessments, title and registration fees, insurance, and like charges associated with the receipt of the GRAND PRIZE, or any other prize, are the sole responsibility of the winner. The winner of the GRAND PRIZE will be required to make a payment of taxes in the amount based upon the fair market value of the GRAND PRIZE at the time of accepting the prize. The GRAND PRIZE must be picked up at the local participating Toyota dealership no later than 30 days after the drawing.

**EXTENSION OF RAFFLE:** AJA reserves the right, and at its own discretion and option, to extend the drawing date of the RAFFLE, if less than 4000 tickets are sold by May 29, 2009.

**AMENDMENT OF OFFICIAL RULES:** AJA also reserves the right, exercisable at its own discretion, to cancel, terminate, modify or suspend the RAFFLE, if, for any reason, the integrity or fairness, or viability of the RAFFLE is compromised.
